We would like to apprise your good selves that as per the past practice, the school fee is accepted in the school fee counter from 1st to 20th of every month without late fine through the ATM/Debit Card swap only. **No Cash payment will be accepted.**

1. The late fine of ₹10 will be charged w.e.f. 21st to 30th/31st of the month.
2. In case of non-payment of fee for continuously three months, the name of the students will be struck off and may be re-admitted on request with a late fine charge of ₹250/- (3 to 5 months), ₹500/- (6 to 11 months) and ₹1000/- (12 months and above) as per norms.
